Senator Zaun was excused until he arrives.

Minutes from the January 11, 2022 meeting were approved as submitted.

Representatives from Iowa Alliance for Arts Education presented.

Democrat Senators caucused at 1:29pm. The meeting reconvened at 1:50pm

Chairwoman Senator Sinclair recognized Senator Cournoyer for [SSB 3002](#). Senator

Cournoyer introduced [SSB 3002](#), delivered the subcommittee report, and gave

opening remarks on the bill. There was no discussion and Chairwoman Senator

Sinclair recognized Senator Cournoyer who moved passage of [SSB 3002](#). A short

form vote was taken, none opposed, and [SSB 3002](#) passed as a committee bill.

Chairwoman Senator Sinclair recognized Senator Kraayenbrink for [SSB 3004](#).

Senator Kraayenbrink introduced [SSB 3004](#), delivered the subcommittee report, and

gave opening remarks on the bill. Senator Kraayenbrink offered amendment [SSB](#)

[3004](#).2665 and gave remarks. There was no discussion and the amendment passed on

a short form vote. There was no discussion on [SSB 3004](#), as amended, and

Chairwoman Senator Sinclair recognized Senator Kraayenbrink for closing

comments. Senator Kraayenbrink moved passage of [SSB 3004](#), as amended. A short

form vote was taken, none opposed, and [SSB 3004](#), as amended, passed and was

moved to the calendar under Rule 40.

Chairwoman Senator Sinclair relinquished the chair to vice chair Senator J Taylor.

Chairman Senator J Taylor recognized Senator Sinclair for [SSB 3005](#). Senator

Sinclair introduced [SSB 3005](#), delivered the subcommittee report, and gave opening

remarks on the bill. Senator Sinclair offered amendment [SSB 3005](#).2664 and gave

remarks. There was no discussion and the amendment passed on a short form vote.

Chairman Senator J Taylor recognized Senator Celsi for remarks on subcommittee

meeting times. Chairman Senator J Taylor recognized Senator Sinclair. Senator

Sinclair gave closing comments on [SSB 3005](#), as amended, and moved its passage. A

short form vote was taken, none opposed, and [SSB 3005](#), as amended, passed and was

moved to the calendar under Rule 40. Chairman Senator J Taylor relinquished the

chair back to Senator Sinclair.

Chairwoman Senator Sinclair recognized Ranking Member Senator Quirmbach for

comments. Ranking Member Senator Quirmbach offered comments on the timing of

subcommittee meetings in relationship to the full committee meeting.

Senator Goodwin moved to adjourn. Meeting adjourned at 1:59PM.
