Senator Brown called up [SSB 3049](#) with Senator Koelker.
Senator Koelker introduced [SSB 3049](#) and provided her opening remarks.
Senator Brown asked for further discussion on the bill. Seeing none Senator Brown recognized Senator Koelker for closing remarks on [SSB 3049](#).
Senator Koelker moved the bill.
Senator Smith requested short form vote on the bill.
Voice vote: YEAS: 12. NAYS: 0. Excused: 1.

Senator Brown asked if there was any other business to come before the committee.
Seeing none Senator Klimesh moved to adjourn the meeting.
