The State Government committee meeting began at 2:32 pm. The previous minutes were approved and attendance was dispensed of. Chairman Kaufmann announced both parties would immediately go to caucus. The meeting reconvened at 3:09 pm. Chairman Kaufmann transferred the gavel to Vice Chair Boden. Chair Boden recognized Representative Kaufmann for [HF 800](#). Representative Kaufmann introduced [HF 800](#) and announced there is an amendment. Representative Kaufmann introduced Amendment .2707 to [HF 800](#). After discussion, Representative Kaufmann made the motion to move the Amendment. Chairwoman Boden made the motion to move the Amendment short form. It passed. Chairwoman Boden then went back to Representative Kaufmann who spoke on [HF 800](#), as amended. There was discussion. Representative Kaufmann moved [HF 800](#), as amended. Chairwoman Boden made the motion to move [HF 800](#) as amended and called for clerk to take roll. [HF 800](#), as amended passed with a vote of 14 ayes (Kaufmann, Boden, Bacon, Bloomingdale, Bossman, Jacobsen, Jones, Lundgren, A. Meyer, Mitchell, T. Moore, Nordman, Sexton, Siegrist) 8 nays (Mascher, Cohoon, Donahue, Gjerde, Hunter, Nielsen, Winckler, Wolfe) and 1 excused (Kurth). [HF 800](#) as amended moves to the floor as a committee bill.
