Chairwoman Ann Meyer recognized Representative Fry for opening remarks on [HSB 510](#): *A bill for an Act relating to payments to child care providers from families participating in the state child care assistance program.*

The bill moved and passed with a vote of 14 Ayes (Representatives Meyer, Bradley, Andrews, Bacon, Bergan, Boden, Bush, Dolecheck, Forbes, Fry, Jeneary, Lundgren, Moore, Osmundson, Sunde), 6 Nays (Wessel-Kroeschell, Anderson, Brown-Powers, Ehlert, Forbes, Mascher), and 1 Absent. The bill will move to the House Floor as a Human Resources Committee bill.
