[SSB 3040](#) passed unanimously on a Short Form Vote with 1 Excused. Chair Sweeney recognized Senator Shipley for [SSB 3041](#). Senator Shipley introduced [SSB 3041](#), delivered the subcommittee report, and gave opening remarks on the bill. Chair Sweeney asked for discussion; no discussion. [SSB 3041](#) passed unanimously on a Short Form Vote with 1 Excused. Senator Cournoyer moved to approve the minutes for the 1/18/22 meeting. The minutes were approved unanimously.
