Chairwoman Ann Meyer recognized Representative Fry for opening remarks on [HF 2017](#): *A bill for an act relating to provisional licensing of interns enrolled in a doctoral degree program in psychology.*

The bill moved and passed with a vote of 18 Ayes (Representatives Meyer, Bradley, Wessel-Kroeschell, Anderson, Andrews, Bacon, Bergan, Boden, Brown-Powers, Bush, Dolecheck, Forbes, Fry, Jeneary, Lundgren, Mascher, Moore, Osmundson), 0 Nay, and 3 Absent. The bill will move to the House Floor as a Human Resources Committee bill.

Chairwoman Ann Meyer recognized Representative Boden for opening remarks on [HF 2031](#): *A bill for an act prohibiting certain health carriers from excluding certain out-of-state health care professionals from participating as providers, via telehealth, under the carriers' policies, plans, and contracts, and including effective date and applicability provisions.*
