Chairman Bacon recognized Representative McClintock for [HSB 545](#). Representative McClintock introduced [HSB 545](#). There was discussion.

Representative McClintock moves the bill and it passes unanimously. 20 yays to 0 nays with Smith excused.

Chairman Bacon recognized Representative Baxter for [HSB 609](#). Representative Baxter announced there is an Amendment. 2952. After discussion, Representative Baxter moves the amendment. Chairman Bacon moved the amendment shortform and the amendment passed unanimously.

[HSB 651](#) passes with a vote of 13 yeas (Bacon, Jeneary, Baxter, Bradley, Cohoon, Fisher, Gerhold, Jacoby, Latham, Maxwell, Mommsen, Siegrist, Thorup) 7 Nays (Brown-Powers, Bennett, Bohannon, Hall, Judge, Mommsen, Thede) with Smith excused.

Representative Bacon returns as Chair of the committee.

Representative Fisher is recognized for [HF 2057](#). There is discussion.

Representative Fisher moves the bill. Chairman Bacon moves [HF 2057](#) and asked the clerk to call roll. [HF 2057](#) passes with a vote of 15 yea (Bacon, Jeneary, Baxter, Bohannon, Bradley, Cohoon, Fisher, Gerhold, Latham, Maxwell, McClintock, Mommsen, Siegrist, Thorup) to 5 nay (Brown-Powers, Bennett, Hall, Hacoby, Thede) with Smith excused.
