Chair Senator Sinclair recognized Senators Celsi and Quirnbach for remarks on the bill. Chair Senator Sinclair recognized Senator Goodwin for closing comments on the bill. Senator Goodwin moved the bill and a short form vote was taken, with Senators Quirnbach, Celsi, Smith and Trone Garriott voting nay, and Senator Giddens excused. [SSB 3146](#) passed and will be moved to the calendar.
