Chairman Shipley asked for any changes or corrections to the Minutes from the previous meeting. Hearing none, the Minutes were approved as drafted.

Subcommittee assignments were distributed.

Chairman Shipley announced the bills to be considered: [SSB 3087](#), [SF 2170](#), [SF 2153](#), [SF 2096](#), [SSB 3120](#), [SSB 3119](#), [SF 2227](#), [SF 2223](#), [SSB 3121](#) and [SSB 3117](#).

Chairman Shipley recognized Senator Garrett for [SSB 3087](#). Senator Garrett introduced the bill, provided the subcommittee report, and gave opening comments on the bill. Chairman Shipley opened the floor for discussion. Chairman Shipley recognized Senators Hogg and Quirmbach who made comments on the bill. Chairman Shipley recognized Senator Williams who made comments on the bill. [SSB 3087](#)

passed 7 to 4 on a short form vote with Senators Smith, Hogg, Quirmbach and Taylor voting nay. The bill moves to the Senate calendar as a committee bill under Rule 40.

Chairman Shipley recognized Senator Garrett for [SF 2170](#). Senator Garrett introduced the bill, provided the subcommittee report, and gave opening comments on the bill.

Chairman Shipley opened the floor for discussion of the amendment.
