The meeting came to order at 9:21 AM.

Chairman Senator Edler announced bills for consideration: [SF 2216](#), [SSB 3144](#), [SF 2028](#), [SF 2258](#), [SSB 3122](#), and [SSB 3145](#).

Chairman Senator Edler relinquishes the Chair to Vice Chair Senator Costello for consideration of [SF 2216](#) and [SSB 3144](#).

Senator Edler provided the subcommittee report and gave comments on [SF 2216](#).

Senator Costello opened the floor to discussion.

Senator Costello recognized Senator Bolkcom who gave comments.

Seeing no further discussion, Senator Costello recognized Senator Edler for closing comments on the bill. Senator Edler moved the bill.

[SF 2216](#) passes 12-1 on a short form voice vote with Senator Bolkcom voting no. [SF 2216](#) moves to the Calendar as an individual bill.

Senator Edler provided the subcommittee report on [SSB 3144](#) and gave comments on the bill.

Senator Costello opened the floor to discussion.

Senator Costello recognized Senator Trone Garriott who made comments.

Seeing no further discussion, Senator Costello recognized Senator Edler for closing comments on [SSB 3144](#). Senator Edler provided closing comments and moved the bill.

[SSB 3144](#) passes unanimously on a short form voice vote and moves to the Calendar as a committee bill under Rule 40.

Vice Chair Senator Costello relinquishes the Chair back to Chairman Senator Edler.

Chairman Senator Edler recognized Senator Johnson for [SF 2028](#). Senator Johnson explained the results of the subcommittee meeting on [SF 2028](#) and gave opening comments on the bill. Senator Johnson states there is an amendment.

Chairman Senator Edler recognized Senator Johnson for comments on Amendment 2028.3219. Senator Johnson provided comments on the amendment.

Chairman Senator Edler opened the floor to discussion.

Chairman Senator Edler recognized Senator Trone Garriott who asked Senator Johnson to yield for a question. Senator Johnson responded.

Amendment 2028.3219 passes unanimously on a short form voice vote.

[SF 2028](#) as amended passes 8-5 with Senators Mathis, Bolkcom, Jochum, Ragan, and Trone Garriott voting no. [SF 2028](#) as amended moves to the Calendar as a committee bill under Rule 40.  
Chairman Senator Edler recognized Senator Costello for [SF 2258](#). Senator Costello provided the subcommittee report and gave opening comments on the bill.  
Chairman Edler opened the floor to discussion.  
Chairman Senator Edler recognized Senator Ragan who made comments.

Chairman Senator Edler recognized Senator Costello for comments on Amendment 3239. Senator Costello provided comments on the amendment. Chairman Senator Edler opened the floor to discussion.

[SSB 3122](#) as amended passes unanimously on a short form voice vote. [SSB 3122](#) as amended moves to the Calendar as a committee bill under Rule 40.  
Chairman Senator Edler announces brief time of recess to wait for amendment on [SSB 3145](#).  
Chairman Senator Edler recognized Senator Costello who provided the subcommittee report on [SSB 3145](#) and gave opening comments on the bill. Senator Costello states there is an amendment.  
Chairman Senator Edler recognized Senator Costello for opening comments on Amendment 3242.  
Chairman Edler opened the floor to discussion on the amendment.  
Chairman Senator Edler recognized Senator Jochum who made comments and asked Senator Costello to yield. Senator Costello replied. Senator Jochum asked Chairman Edler for committee consent to seek input from a representative of DHS or IDPH. The Committee consented to the request. A member from each department responded.  
Seeing no further discussion, Chairman Senator Edler recognized Senator Costello for closing comments on amendment 3242. Senator Costello provided closing comments and moved the amendment.  
Amendment 3145.3242 passes unanimously on a short form voice vote.  
Chairman Senator Edler opened the floor to discussion on [SSB 3145](#) as amended.  
Chairman Senator Edler recognized Senator Jochum for comments on the amended bill.

Chairman Senator Edler recognized Senator Trone Garriott who made comments. Chairman Senator Edler recognized Senator Ragan who asked Senator Costello a question. Senator Costello responded. Seeing no further discussion, Chairman Senator Edler recognized Senator Costello for closing comments on [SSB 3145](#) as amended. Senator Costello provided closing comments and moved the bill. [SSB 3145](#) passes 8-5 with Senators Mathis, Bolkom, Jochum, Ragan, and Trone Garriott voting no. [SSB 3145](#) as amended moves to the Calendar as a Committee Bill under Rule 40.
