Chairman Holt recognized Representative A. Meyer for opening comments on [HSB 7](#). There was discussion. Rep. A. Meyer was recognized for closing remarks and moved [HSB 7](#). Chairman Holt moved [HSB 7](#) as a committee bill on a roll call vote of 15 ayes (Representatives Holt, Gustoff, Wilburn, Collins, Dunwell, Gustafson, Jones, Kaufmann, Lohse, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C. and Wheeler), and 4 nays (Representatives James, Scheetz, Srinivas and Wessel-Kroeschell).
