Chairman Holt called the Judiciary Committee meeting to order at 10:19 a.m.

Chairman Holt recognized Representative Collins for opening comments on [HJR 2](#) and he indicated there were amendments. Chairman Holt recognized Representative James for opening comments on Amendment .308. There was discussion. Rep. James was recognized for closing remarks on Amendment .308 and moved the amendment.

Rep. Collins asked for a division and record, Representative Wheeler seconded.

Amendment .308 failed on a roll call vote of 7 ayes (Representatives Wilburn, James, Meyer, B., Olson, Scheetz, Srinivas, and Wessel-Kroeschell) and 14 nays

(Representatives Holt, Gustoff, Collins, Dunwell, Gustafson, Jones, Kaufmann, Lohse, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and Wheeler). No additional amendments were called up and there was discussion on [HJR 2](#). Rep.

Collins was recognized for closing comments and moved the bill. Chairman Holt moved [HJR 2](#) to the floor as a committee bill on a roll call vote of 13 ayes

(Representatives Holt, Gustoff, Collins, Dunwell, Gustafson, Jones, Kaufmann, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and Wheeler) and 8 nays (Representatives Wilburn, James, Lohse, Meyer, B., Olson, Scheetz, Srinivas, and Wessel-Kroeschell).

Chairman Holt recognized Representative Lohse for opening comments on [HF 114](#).

With no discussion, Rep. Lohse was recognized for closing comments and moved [HF 114](#). Chairman Holt moved [HF 114](#) as a committee bill with a unanimous roll call vote of 21 ayes.
