Chairman Young requested roll call vote on amendment 167.479(2). Representative Lundgren gave closing remarks on HSB 167, and moved the bill. Roll call vote of 15 ayes (Representatives Lundgren, Young, Best, Bloomingdale, Devoe, Graber, Kniff McCulla, Lohse, Mohr, G., Nordman, Thompson, P., Thomson, C. Vondran, Wills, J., Wilz, H.) 8 nays (Judge, Bagniewski, Forbes, Jacoby, Kressig, Nielsen, Scholten, Srinivas). HSB 167 now goes to the floor as a committee bill. Chairman Young, turned the Chair back over to Chairwoman Lundgren. Chairman Lundgren recognized Representative Young for opening statements on HSB 324. There is an amendment. Representative Young introduced amendment 324.556(2). Representative Young motioned to pass short form, amendment 324.556(2) passed. Representative Nordman motioned to pass short form, amendment 175.547(1) passed. Representative Nordman gave closing remarks on <u>HSB 175</u>, as amended and moved the bill. Chairwoman Lundgren moved <u>HSB 175</u> as amended to the floor with unanimous roll call vote of 23 ayes 0 nays. <u>HSB 175</u> as amended now moves to the floor as a committee bill.

Chairwoman Lundgren recognized Representative Wilz, J., for opening statements on <u>HSB 190</u>. Representative Wilz gave closing remarks on <u>HSB 190</u> and moved the bill.
