Chairman Holt called the Judiciary Committee meeting to order at 10:03 a.m. Roll call was taken with all members present, except Representative Gustafson was excused until he arrived.

Chairman Holt then recessed the meeting.

Chairman Holt called the meeting back to order at 12:36 a.m. on Friday, March 3, 2023, and excused Representative Wheeler until he arrived. Ranking Member Wilburn excused Representative Brian Meyer.

Chairman Holt recognized Representative Gustoff for opening comments on [HSB 207](#). There was discussion. Rep. Gustoff moved [HSB 207](#). Chairman Holt moved [HSB 207](#) as a committee bill with a unanimous roll call vote of 20 ayes and 1 excused (Representative Meyer, B.).

Chairman Holt recognized Representative Kaufmann for opening comments on [HF 299](#). Rep. Kaufmann indicated there was Amendment .782 and was recognized for opening comments. There was discussion. With no further discussion, Rep. Kaufmann moved the amendment short form. The amendment passed. With no further discussion, Rep Kaufmann moved [HF 299](#), as amended. Chairman Holt moved [HF 299](#), as amended as a committee bill on a roll call vote of 12 ayes (Representatives Holt, Gustoff, Collins, Dunwell, Kaufmann, Lohse, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and Wheeler), 6 nays (Representatives Wilburn, Gustafson, James, Olson, Scheetz, and Wessel-Kroeschell), 2 Rule-76 (Representatives Jones and Srinivas), and 1 excused (Representative Meyer, B.).

Chairman Holt recognized Representative Nordman for opening comments on [HF 321](#). There was discussion. With no further discussion, Rep. Nordman offered closing comments and moved [HF 321](#). Chairman Holt moved [HF 321](#) as a committee bill with a roll call vote of 19 ayes, 1 nay (Representative Jones), and 1 excused (Representative Meyer, B.).

Chairman Holt turned the Chair over to Vice Chair Gustoff.

Chair Gustoff recognized Representative Holt for opening comments on [HSB 208](#). There was discussion. With no further discussion, Rep. Holt was recognized for closing remarks and moved [HSB 208](#). Chair Gustoff moved [HSB 208](#) as a committee bill on a roll call vote of 12 ayes (Representatives Holt, Gustoff, Collins, Dunwell, Gustafson, Kaufmann, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and

Wheeler) and 8 nays (Representatives Wilburn, James, Jones, Lohse, Olson, Scheetz, Srinivas, and Wessel-Kroeschell) and 1 excused (Representative Meyer, B.).

Chair Gustoff recognized Representative Holt for opening comments on [HSB 214](#). Rep. Holt indicated there was Amendment .777 and was recognized for opening remarks on the amendment. There was discussion. With no further discussion, Rep. Holt was moved the amendment short form. The amendment passed. There was discussion and Representative Jones indicated there was another Amendment .810. She was recognized for opening remarks on Amendment .810. There was discussion. With no further discussion, Rep. Jones moved the amendment. A division and record were called for. Chair Gustoff called for a record roll call vote of Amendment .810. The amendment failed with 8 Ayes (Representatives Wilburn, James, Jones, Lohse, Olson, Scheetz, Srinivas, and Wessel-Kroeschell), 11 Nays (Representatives Holt, Gustoff, Collins, Dunwell, Kaufmann, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and Wheeler) and 2 excused (Representatives Gustafson and Meyer, B.). There was discussion on [HSB 214](#), as amended. With no further discussion, Rep. Holt was recognized for closing remarks and he moved [HSB 214](#), as amended. Chair Gustoff moved [HSB 214](#), as amended on a roll call vote of 12 ayes (Representatives Holt, Gustoff, Collins, Dunwell, Gustafson, Kaufmann, Meyer, A., Nordman, Stone, Thompson, P., Thomson, C., and Wheeler) and 8 nays (Representatives Wilburn, James, Jones, Lohse, Olson, Scheetz, Srinivas, and Wessel-Kroeschell) and 1 excused (Representative Meyer, B.).

Chair Gustoff turned the Chair back to Chairman Holt.
