Consideration of Bills:

Chairman Kaufmann recognized Rep Jones for HF 268. Rep Jones made opening comments on the bill, and there is an amendment. Chairman Kaufmann recognized Rep Jones for amendment .1730. Rep Jones explained the amendment and opened the floor. There was discussion, and Rep Jones moved the amendment. Chairman Kaufmann moved the amendment to a vote in short form, and the amendment carries. On the bill as amended, there was discussion. Wills, and Wulf.) the amendment fails. Back on the bill, there was discussion. Rep Jones made closing comments, and Chairman Kaufmann moved the bill. with 24 ayes, the bill passed unanimously and moves forward as a committee bill.

Chairman Kaufmann moved the bill to a vote. With 24 ayes, the bill passed unanimously and moves forward as a committee bill. Chairman Kaufmann recognized Rep Jones for HSB 241. Croken, Forbes, Gjerde, Isenhart, Judge, Kurth, Lundgren, Nielsen, Siegrist, and Wilson.) the bill passed and moves forward as a committee bill. With no further business, Rep Jacoby moved to arise, and Chairman Kaufmann adjourned the meeting at 10:20
