Senator Kraayenbrink called the meeting to order.

Attendance was taken silently by the committee secretary. The minutes of the last meeting were approved. Subcommittee assignments were distributed electronically. Senator Kraayenbrink announced bills [HF 709](#) and [SSB 1219](#) for consideration by the committee.

Senator Kraayenbrink turned the chair over to Vice-Chair Zumbach. Senator Zumbach recognized Senator Kraayenbrink for the subcommittee report and opening remarks on [HF 709](#). Senator Kraayenbrink introduced Amendment 1880. With no comments from the floor, Senator Kraayenbrink moved Amendment 1880. Short form vote was requested. Amendment 1880 was unanimously approved.

Back on [HF 709](#) with committee amendment. With no further discussion, Senator Zumbach recognized Senator Kraayenbrink for closing comments on [HF 709](#) with committee amendment. Senator Kraayenbrink simply moved the bill. Short form vote was requested. [HF 709](#) with committee amendment passed unanimously.

Vice-Chair Zumbach turned the meeting back over to Chair Kraayenbrink.

Senator Kraayenbrink recognized Senator Koelker for the subcommittee report and opening remarks on [SSB 1219](#). Senator Koelker introduced Amendment 1876. With no comments from the floor, Senator Koelker moved Amendment 1876. Short form vote was requested. Amendment 1876 was unanimously approved.

Back on [SSB 1219](#) as amended. Senator Kraayenbrink recognized Senator Petersen for opening comments on a second amendment, Amendment 1902. Senator Kraayenbrink entertained comments from the floor. Senator Koelker was recognized for comment. Senator Kraayenbrink recognized Senator Petersen for closing comments on Amendment 1902. Senator Petersen moved Amendment 1902 to [SSB 1219](#). A record vote was requested. Amendment 1902 to [SSB 1219](#) was defeated with all Democrat committee members present voting yea; all Republican committee members present voting nay.

Back on [SSB 1219](#) as amended. Senator Kraayenbrink recognized Senator Petersen for comment. Senator Kraayenbrink recognized Senator Koelker for closing comments. Senator Koelker moved [SSB 1219](#) as amended. Short form vote was requested. [SSB 1219](#) as amended was unanimously approved and moved to the calendar under Rule 40.

With no further business to come before the committee, Senator Green moved to adjourn.
