Chairman Kaufmann called the Ways and Means committee to order at 7:11 pm in Room 102.

Chairman Kaufmann dispensed of the Roll.

Chairman Kaufmann handed the gavel over to Rep. Lundgren who made the motion to dissolve committee and go to subcommittee as a whole. The motion passed by majority voice vote.

Representative Kaufmann introduced [SF 574](#) and opened the floor for discussion. There were questions and discussion. Deanna Triplett from the Economic Development Authority was introduced as a guest to take questions from the committee members and attendees.
