*Chairman Best called on Rep. Wulf to introduce [HF 2092](#). Chairman Best recognized Rep. Wulf for opening remarks on amendment [HF 2092](#).2691. The amendment passed on a voice vote. There was discussion. Rep. Wulf moved [HF 2092](#), as amended, and Chairman Best asked the clerk to call roll.
