Vice Chairwoman Koelker recognized Senator Dawson for <u>SSB 3179</u> and its amendment .4022. The amendment was discussed and passed unanimously on a short form vote. The bill as amended was discussed and passed unanimously on a short form vote. The bill moves to the calendar under rule 40.

Vice Chairwoman Koelker recognized Senator Dawson for <u>SSB 3195</u> and its amendment .4004. The amendment was discussed and pass unanimously on a short form vote. The bill as amended was discussed and passed 15-3 on a short form vote with Senators Winckler, Petersen, and T. Taylor voting "nay".

Vice Chairwoman Koelker yielded the chair back to Chairman Dawson.

Chairman Dawson recognized Senator Cournoyer for <u>HF 2639</u> and its amendment .3952. The amendment was discussed and passed unanimously on a short form vote. The bill as amended was discussed and a voice vote was requested. The bill passed 12-6 with Senators Petersen, Winckler, Quirmbach, Jochum, and T. Taylor, and Dotzler voting "nay".

Chairman Dawson recognized Senator Klimesh for <u>SF 570</u> and its amendment .4006. The amendment was discussed and passed unanimously on a short form vote. The bill as amended was discussed and also passed unanimously on a short form vote. The bill moved to the calendar under rule 40.

Chairman Dawson recognized Senator Dickey for <u>SF 555</u> and its amendment .3967. The amendment was discussed and passed unanimously on a short form vote. The bill as amended was discussed and also passed unanimously on a short form vote. The bill moved to the calendar under rule 40.

Chairman Dawson recognized Senator Sweeney for <u>SF 2155</u>. The bill was discussed and passed 17-1 on a short form vote with Senator Dickey voting "nay".
