Senator Kraayenbrink called the meeting to order.

Senator Kraayenbrink announced bills [SSB 3198](#), [SSB 3199](#), [HF 2658](#), and [SSB 3197](#) for consideration by the committee.

Senator Kraayenbrink recognized Senator Lofgren for the subcommittee report and opening remarks on [SSB 3198](#). Senator Kraayenbrink entertained comments from the floor. Senator Dotzler was recognized for comment. With no further discussion, Senator Kraayenbrink recognized Senator Lofgren for closing comments on [SSB 3198](#). Senator Lofgren moved the bill. A short form vote was requested. [SSB 3198](#) was unanimously approved and moved to the Calendar as a committee bill.

Senator Kraayenbrink recognized Senator Rowley for the subcommittee report and opening remarks on [SSB 3199](#). Senator Kraayenbrink entertained comments from the floor. Senators Celsi and Petersen were recognized for comment. With no further discussion, Senator Kraayenbrink recognized Senator Rowley for closing comments on [SSB 3199](#). Senator Rowley moved the bill. A short form vote was requested. [SSB 3199](#) passed with 13 yeas; 7 nays (Petersen, Celsi, Donahue, Dotzler, Giddens, T. Taylor, Winckler) and moved to the Calendar as a committee bill.

Senator Kraayenbrink recognized Senator Costello for the subcommittee report and opening remarks on [HF 2658](#). Senator Kraayenbrink entertained comments from the floor. Senator Donahue was recognized for comment. With no further discussion, Senator Kraayenbrink recognized Senator Costello for closing comments on [HF 2658](#). Senator Costello moved the bill. A short form vote was requested. [HF 2658](#) was unanimously approved and moved to the Calendar.

Senator Kraayenbrink turned the chair over to Vice-Chair Zumbach.

Senator Zumbach recognized Senator Kraayenbrink for the subcommittee report and opening remarks on [SSB 3197](#). Senator Kraayenbrink introduced Amendment 4023. Senator Zumbach entertained comments from the floor. With no discussion, Senator Kraayenbrink was recognized for closing comments and moved amendment 4023. Short form vote was requested. Amendment 4023 was unanimously approved.

Senator Kraayenbrink was recognized for closing comments and moved [SSB 3197](#) as amended. Short form vote was requested. [SSB 3197](#) as amended was unanimously approved. [SSB 3197](#) as amended was moved to the Calendar as a committee bill.
