Chairman Vondran moved [HSB 166](#) as an amended committee bill with a passing roll call vote of 16 Ayes (Vondran, Wengryn, Gjerde, Cisneros, Dieken, Gearhart, Gosa, Henderson, Hermanson, Holt, Meggers, Meyer, B., Mohr, G., Rinker, Thomson, C., Wills, J), 4 Nays (Amos Jr., Brown-Powers, Kressig, Levin) and 3 excused (Representatives Fisher, Gustoff, Wessel-Kroeschell.)

Chairman Vondran recognized Representative Meggers for opening remarks on [HF 40](#). A discussion was held. Closing remarks were made by Representative Meggers and a motion to vote was made. Chairman Vondran moved [HF 40](#) as a committee bill with a unanimous roll call vote of 20 Ayes, 0 Nays, and 3 excused (Representatives Fisher, Gustoff, Wessel-Kroeschell).

Chairman Vondran recognized Representative Meggers for opening remarks on [HF 98](#). A discussion was held. Closing remarks were made by Representative Meggers and a motion to vote was made. Chairman Vondran moved [HF 98](#) as a committee bill with a unanimous roll call vote of 20 Ayes, 0 Nays, and 3 excused (Representatives Fisher, Gustoff, Wessel-Kroeschell.)

A discussion was held, and a short form vote was requested. The Ayes appear to have it and the amendment passes. Chairman Vondran recognized Representative Meggers for further comments on [HF 231](#) as amended. A discussion was held and a motion to vote was made. Chairman Vondran moved [HF 231](#) as an amended committee bill with a passing unanimous roll call vote of 20 Ayes, 0 Nays, and 3 excused (Representatives Fisher, Gustoff, Wessel-Kroeschell).
