The Chair called the Natural Resources Committee to Order at 10:46.

Chair Wulf recognized Representative Golding for opening remarks on [HF 205](#), An act relating to hunting seasons during which a non-ambulatory hunter may use certain firearms with a specifically issued deer license.

[HF 205](#) passed 13 Ayes (Wulf, Golding, Andrews, Barker, Collins, Fisher, Gearhart, Harris, Hermanson, Mommsen, Sexton, Smith, Wengryn) and 8 Nays (Kurth, Gjerde, Jacoby, Judge, Levin, Nielsen, Scholten, Turek), having passed the Natural Resources committee the bill will go to the house floor as a Natural Resources Committee Bill.

Chair Wulf recognized Representative Harris for opening remarks on [HSB 163](#), an act relating to enclosed dock on private structures and requiring insurance.

Representative Harris offered and was recognized to comment on an amendment to [HSB 163](#) (Amendment [HSB 163.469](#)) and passed voice vote.

[HF 205](#) as amended passed 21 Ayes (Wulf, Golding, Andrews, Barker, Collins, Fisher, Gearhart, Harris, Hermanson, Mommsen, Sexton, Smith, Wengryn, Kurth, Gjerde, Jacoby, Judge, Levin, Nielsen, Scholten, Turek) and 0 Nays, having passed the Natural Resources committee the bill will go to the house floor as a Natural Resources Committee Bill as amended.
