Senator Kraayenbrink announced the following bills for consideration by the committee: [SF 2420](#), [SF 2282](#) w/amendment, [SSB 3182](#), and [SSB 3107](#) w/amendment.

Senator Kraayenbrink recognized Senator Shipley for the subcommittee report and opening remarks on [SF 2420](#).

Senator Kraayenbrink entertained comments from the floor. Senator Petersen was recognized for comment. Senator Shipley asked for unanimous consent to recognize IDALS. With no objection, IDALS was recognized for comment.

With no further discussion, Senator Kraayenbrink recognized Senator Shipley for closing comments on [SF 2420](#).

Senator Shipley moved the bill. Short form vote was requested. [SF 2420](#) passed unanimously with 3 excused (Garrett, Rowley, and Whitver) and moved to the calendar as a committee bill.

Senator Kraayenbrink recognized Senator Reichman for the subcommittee report and opening remarks on [SF 2282](#).

Senator Reichman introduced Amendment 3099. Senator Kraayenbrink entertained comments from the floor. With no discussion, Senator Reichman was recognized for closing comments and moved amendment 3099. Short form vote was requested. Amendment 3099 was unanimously approved.

Back on [SF 2282](#) as amended. Senator Kraayenbrink entertained comments from the floor. With no discussion,

Senator Kraayenbrink recognized Senator Reichman for closing comments on [SF 2282](#) as amended. Senator Reichman moved the bill. A short form vote was requested. [SF 2282](#) as amended passed unanimously with 3 excused (Garrett, Rowley, and Whitver) and moved to the calendar as a committee bill.

Senator Kraayenbrink recognized Senator Costello for the subcommittee report and opening remarks on [SSB 3182](#).

Senator Kraayenbrink entertained comments from the floor. Senators Donahue and Petersen were recognized for comment. With no further discussion, Senator Kraayenbrink recognized Senator Costello for closing comments on [SSB 3182](#). Senator Costello moved the bill. A record vote was requested. [SSB 3182](#) passed with 12 yeas; 7 nays (Petersen, Blake, Donahue, Dotzler, Knox, Staed, Winckler); 3 excused (Garrett, Rowley, and Whitver) and moved to the calendar as a committee bill.

Senator Kraayenbrink turned the chair over to Senator Zumbach. Senator Zumbach recognized Senator Kraayenbrink for the subcommittee report and opening remarks on [SSB 3107](#). Senator Kraayenbrink introduced Amendment 2963.

Senator Zumbach entertained comments from the floor. Senator Blake was recognized for comment. Senator Kraayenbrink was recognized for closing comments and moved amendment 2963. Short form vote was requested.

Amendment 2963 was unanimously approved.

Back on [SSB 3107](#) as amended. Senator Zumbach entertained comments from the floor. With no discussion, Senator Kraayenbrink was recognized for closing comments and moved [SSB 3107](#) as amended. A short form vote was requested. [SSB 3107](#) as amended passed unanimously with 3 excused (Garrett, Rowley, and Whitver) and moved to the calendar as a committee bill.
