Chairperson Smith called the January 28, 2008 meeting of the Human Resource Committee to order at 4pm in room 103. Roll call was taken and quorum was present. Minutes of the January 23, 2008 Human Resource committee meeting were approved.

Chairperson advised the committee that he would be requesting the rules be suspended so that the committee could discuss HF 2057. Unanimous consent was given by the committee

Chairperson Smith recognized Representative Wessel-Kroeschell for discussion of HSB 504. Representative Wessel-Kroeschell was recognized by Chairperson Smith for comments on Amendment .501. Vote was held until after the Republicans caucused.

Chairperson Smith sought to dissolve into a whole, so that HF 2057 could be discussed as a subcommittee. Chairperson Smith presented information on HF 2057. Voice vote to bring HF 2057 before the committee and was approved. Vote was held until after the Republicans caucused.

Republicans caucused at 4:20pm. Democrats caucused as well.

Chairperson Smith called the committee back to order at 4:30 pm. Chairperson Smith advised the committee was deferring on HSB 504.

Chairperson Smith turned the committee over to Vice Chair Abdul-Samad. Chairperson Abdul-Samad recognized Representative Smith for comments on HF 2057. Representative Smith advised the committee would stand at ease awaiting a technical correction to HF 2057.

Chairperson Abdul-Samad called the meeting back to order and recognized Representative Smith for comments regarding Amendment .701. Representative Smith moved Amendment .701 and Representative Heaton seconded the motion. Voice vote was unanimous. Chairperson Abdul-Samad recognized Representative Smith for closing comments on HF 2057 and Representative Smith made motion to move the HF 2057 as amended. Seconded by Representative Foege. Vote was taken with Ayes 19, No 0, Absent 2. HF 2057 as amended will now go to the floor as a committee bill as amended.

Chairperson Abdul-Samad relinquished the Chair back to Representative Smith.

Chairperson Smith assigned the following bills:

HF 2014 Chair Representative Wessel-Kroeschell, Representatives Heaton and Hunter-study of shortage of doctors of psychiatry in Iowa Legislature

HF 2055 Chair Representative Mascher, Representatives Smith and L. Miller requires certification of the performance of an eye examination, when a child is enrolled in kindergarten

HF 2061 Chair Representative Mascher, Representatives T. Olson and Granzow Act relating to a temporary permit to practice dentistry or dental hygiene

HF 2056 Chair Representative Hunter, Representatives Mascher and Heaton Act relating to the subsidization of the personal needs allowance for residents of certain facilities

HF 2067 Chair Representative Petersen, Representatives Wessel-Kroeschell and Soderberg Act relating to local regulation of smoking

Chairperson Smith sought any new business and seeing none Representative L. Miller moved we arise.
