The meeting was called to order by Chair, Representative Gaskill. Roll was called with a quorum being present.

The minutes of the March 3, 2008, meeting were approved.

The following bills were assigned:

HF 2451 A bill for an act relating to the operation of county hospitals and the duties and powers of county hospital trustees. Gaskill Ch, Deyoe, Olson, D.

HF 2470 A bill for an act relating to county medical examiner fees for an inmate death and investigations of deaths that affect the public interest. Schueller Ch, Arnold, Lykam

HF 2476 A bill for an act prohibiting local legislation that prevents local government officials or employees from cooperating with federal officials with regard to the immigration status of persons within the state. Olson, D., Gaskill, Van Fossen

HF 2481 A bill for an act relating to the authority of a county treasurer to refuse renewal of a vehicle registration and collect taxes when the vehicle owner owes delinquent taxes on certain property. Gaskill Ch, Bukta, Rasmussen

The Chair announced that HF 2211 would be considered; HSB 761 was indefinitely postponed; and HF 2272 may be considered.

The Democrats and Republicans went to caucus.

The meeting reconvened. The Chair recognized Representative Taylor for HF 2211: A bill for an act relating to compensation paid to county supervisors. Opening remarks were made. Following questions and comments, Representative Taylor moved passage of the bill. The bill passed unanimously and becomes a committee bill.

The Chair asked for unanimous consent to consider in subcommittee as a whole HF 2272: A bill for an act relating to the exceptions to the conflict of interest restrictions for city officials, city employees, and civil service commissioners. There were no objections. Representative Huser was recognized for opening remarks on HF 2272. Following questions and comments Representative Huser moved passage of the bill in subcommittee. The bill passed unanimously. The subcommittee was dissolved and the Chair asked for unanimous consent to move the bill to the full committee. There were no objections.

Representative Huser was recognized for HF 2272. Following opening remarks, Representative Huser moved passage of the bill. The bill passed unanimously and will become a committee bill.

There being no other business, Representative Clute moved adjournment. The meeting adjourned.
