Chair Huser called the meeting to order at 10:05 am.
Roll was called by the clerk.
The minutes of March 4th 2008 were unanimously approved.

Chair Huser recognized Representative Dandekar on HSB 753. Representative Dandekar gave opening comments on HSB 753 and mentioned there was an amendment.

Chair Huser recognized Representative Dandekar on amendment 201. Representative Dandekar provided opening comments on amendment 201 and after discussion, Representative Dandekar moved amendment 201. The amendment passed on a voice vote of the committee.

Chair Huser asked for discussion on HSB 753 as a whole. After discussion and closing remarks, Representative Dandekar moved HSB 753. Chair Huser announced that HSB 753 as amended passes on a vote of 20-0-1 and will pass to the House floor as a committee bill.

Chair Huser stated for the record that HSB 674 that passed out of transportation last week will be referred to Ways and Means.

Upon reconvening, Chair Huser turned the chair over to Representative Lykam. Acting Chair Lykam recognized Representative Huser on HSB 628. Representative Huser gave opening comments on HSB 628 and mentioned that there were amendments.

Acting Chair Lykam recognized Representative Tjepkes on amendment 302. Representative Tjepkes gave opening comments on amendment 302 and mentioned that there were amendments.

Acting Chair Lykam recognized Representative Huser on amendment 303. Representative Huser gave opening comments on amendment 303, and after discussion moved the amendment to the amendment. The amendment passed on a voice vote.

Acting Chair Lykam recognized Representative Cohoon on amendment 202. Representative Cohoon gave opening comments on amendment 202 and after discussion, moved the amendment to the amendment. The amendment passed on a voice vote.

Acting Chair Lykam asked if there was any discussion on amendment 302 as amended. After discussion, Representative Tjepkes moved amendment 302. Amendment 302 passed on a voice vote.

Acting Chair Lykam asked if there were any questions on HSB 628. After discussion, Representative Huser moved HSB 628 as amended. Acting Chair Lykam announced that HSB 628 passed as amended by a vote of 12-7-2 and will pass to the House Ways and Means Committee.

Acting Chair Lykam returned the chair to Representative Huser.

Seeing no further business to come before the committee, Representative Gipp moved that the committee arise. Chair Huser adjourned the meeting at 11:10 am.
