The Committee considered HF 2066. Representative Reasoner was recognized for opening comments on HF 2066.

The Committee moved to Subcommittee as a Whole at the Chairman's suggestion. Representative Reasoner was recognized for opening remarks on HF 2066 before the Subcommittee.

Representative Reasoner was recognized for opening remarks on Amendment 2066.203. Representative Reasoner asked for consent for the Department of Revenue to explain a section of Amendment 2066.203. Representative Shomshor recognized David Casey of the Department of Revenue for his remarks. Representative Reasoner finished his remarks on Amendment 2066.203. Discussion of Amendment 2066.203 ensued.

Representative Kaufmann was recognized for opening remarks on Amendment 2066.302.

Representative Deyoe was recognized for opening remarks on Amendment 2066.303

Representative Struyk was recognized for opening remarks on Amendment 2066.201.

Representative Reasoner moved House File 2066. House File 2066 passed out of the Subcommittee as a Whole unamended and moved to the Committee.

Representative Reasoner was recognized for closing remarks on Amendment 2066.203. Representative Kaufmann suggested to divide Amendment 2066.203. The division would be as follows: page 2 line 9 through page 3 line 18, Division B. The rest of the amendment will be Division A. Withdraw Division B. With no objections, Amendment 2066.203 was divided. Representative Reasoner was recognized for comments on Division A. Discussion ensued, and seeing no further discussion, Representative Reasoner moved Amendment 2066.203, Division A. Amendment 2066.203, Division A passed by a voice vote.

Representative Kaufmann was recognized for closing remarks on Amendment 2066.302. The Committee passed Amendment 2066.302 by a voice vote.

Representative Deyoe was recognized for closing remarks on Amendment 2066.303. The Committee passed Amendment 2066.303 by a voice vote.

Representative Struyk was recognized for closing remarks on Amendment 2066.201. Division was requested with 10 members for the amendment and 13 members against. Amendment 2066.201 failed.

A motion was requested to indefinitely table HF 2066. By a record vote of 7-17 with one member absent, the motion to table HF 2066 failed. The record vote to indefinitely table HF 2066: Against: Shomshor, Schueller, Davitt, Forristall, Frevert, Grassley, Huser, Jochum, Kaufmann, Kelley, Palmer, Quirk, Reasoner, Thomas, Wendt, Wiencek, Wise. For: Sands, Deyoe, Pettengill, Soderberg, Struyk, Van Fossen, Windschitl. One member absent: Olson, T.

Representative Reasoner moved HF 2066. The bill passed the Committee by a record vote of 18 - 6 with one member absent. The bill will now move to the House Calendar as a Ways & Means Committee bill.

Representative Shomshor generously determined that the rest of the bills scheduled to come before the Ways & Means Committee would be put on next week's agenda. Seeing no further business before the Committee, Representative Van Fossen moved to adjourn.
