Representative Shomshor called the Ways & Means meeting to order. Clerk called roll, and minutes from last meeting were approved.

Representative Shomshor assigned the following bill: HF 2661- Shomshor (Ch.), Reasoner, Sands

Representative Shomshor recognized Representative Thomas for opening remarks on HF 2518. Representative Thomas asked to substitute SF 2267 for HF 2518. Seeing no objections, the substitution was made. Representative Thomas offered Amendment 2267.702, and by a voice vote the amendment passed. Representative Thomas gave closing remarks on SF 2267 and moved the bill. SF 2267 passed as amended by a roll call vote of 23-0 with two members absent. The bill now moves to the House floor.

Representative Shomshor recognized Representative Wendt for opening remarks on HF 2536. Rep. Wendt moved the bill. HF 2536 passed the Committee by a roll call vote of 24-0 with one member absent. The bill now moves to the House floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Jochum for opening remarks on SF 2174. Representative Jochum moved the bill. SF 2174 passed the Committee by a roll call vote of 24-0 with one member absent. The bill now moves to the House floor.

Representative Shomshor recognized Representative Jochum for opening remarks on HF 898. Representative Jochum offered Amendment 898.201, which passed by a voice vote. Representative Jochum gave closing remarks and moved the bill. HF 898 passed the Committee as amended by a roll call vote of 24-0 with one member absent. The bill now moves to the House floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Jochum for opening remarks on SF 385. Representative Jochum offered Amendment 385.203, which passed by a voice vote. Discussion on the bill ensued. Representative Jochum gave closing remarks and moved the bill. SF 385 passed the Committee by a roll call vote of 24-0 with one member absent. The bill now moves to the House floor.
