Chair Huser called the meeting to order at 10:20 am.

Chair Huser recognized Representative Cohoon for SF 34. Representative Cohoon gave opening remarks on SF 34 and announced that there was an amendment. Chair Huser recognized Representative Cohoon on amendment 502.

Representative Cohoon gave opening remarks on amendment 502. After discussion, Representative Cohoon moved amendment 502. Amendment 502 passed the Committee on a voice vote.

Chair Huser asked if there was any further discussion on SF 34 as amended. After discussion, Chair Huser recognized Representative Cohoon for closing remarks. Representative Cohoon moved SF 34 as amended. Chair Huser announced that SF 34 having received a constitutional majority with a vote of 21-0 will pass to the House floor as amended.
