Representative Shomshor recognized Representative Wise for opening remarks on HF 2351. Amendment 2351.504 was introduced, and opening remarks were given on the amendment. Discussion followed. Representative Wise asked the Department of Economic Development to yield for questions. Seeing no further discussion, Representative Wise moved the amendment. Amendment 2351.504 passed by a voice vote. Representative Wise gave closing remarks on HF 2351 as amended. By a roll call vote of 25 to 0, the bill passed. HF 2351 now moves to the House floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Thomas for opening remarks on HF 2518. Amendment 2518.708 was introduced, and opening remarks were given on the amendment. Amendment 2518.708 passed by a voice vote. Seeing no discussion on the bill, Representative Thomas moved the bill as amended. roll call vote of 25 to 0, the bill passed. HF 2518 now moves to the House floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Schueller for opening remarks on HF 903. Amendment 903.301 was introduced, and opening remarks were given on the amendment. Discussion ensued. Amendment 903.301 passed by a voice vote Discussion on the bill followed. Representative Schueller gave closing remarks on HF 903 as amended and moved the bill. By a roll call vote of 25 to 0, HF 903 passed the Committee. The bill now moves to the House Floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Wendt for opening remarks on HF 2623. Discussion followed. Representative Wendt gave closing remarks and moved the bill. By a roll call vote of 17 to 8, HF 2623 passed the Committee. The bill now moves to the House Floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Wendt for opening remarks on HF 2566. Discussion followed. Representative Wendt gave closing remarks and moved the bill. By a roll call vote of 13 to 11 with one member absent, HF 2566 passed the Committee. The bill now moves to the House Floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Reasoner for opening remarks on HF 2632. Amendment 2632.506 was introduced, and opening remarks were given on the amendment. Discussion followed. Amendment 2632.506 passed the Committee by a voice vote. Discussion on the bill as amended ensued. Representative Reasoner gave closing remarks and moved the bill. By a roll call vote of 25 to 0, HF 2632 passed the Committee as amended. The bill now moves to the House Floor as a Ways and Means Committee bill.

Representative Shomshor recognized Representative Davitt for opening remarks on HSB 781. Amendment 781.201 was introduced, and opening remarks were given on the amendment. Amendment 781.201 passed by a voice vote. Seeing no further discussion on the bill, Representative Davitt moved the bill as amended. By a roll call vote of 25 to 0, HSB 781 passed as amended. The bill now moves to the House Floor as a Ways and Means Committee bill.

The Committee recessed at 3:48~p.m. for both parties to caucus. The Committee reconvened at 4:40~p.m.

Representative Shomshor recognized Representative Reasoner for opening comments on HF 2610. Amendment 2610.501 was introduced and Representative Grassley was acknowledged for opening remarks on the amendment. Amendment 2610.501 passed by a voice vote. Representative Forristall was acknowledged for opening remarks on Amendment 2610.302. Amendment 2610.302 passed by a voice vote. Representative Struyk was recognized for Amendment 2610.304. The amendment passed by a voice vote. Seeing no further discussion, Representative Reasoner moved the bill as amended. By a roll call vote of 23-2, HF 2610 moves to the House Floor as a Ways and Means Committee bill.
