Representative Shomshor called the meeting to order at 11:00 a.m. Clerk called roll and minutes from last meeting were approved.

Representative Shomshor assigned SF 2405 to the Subcommittee as a Whole with Representative Thomas assigned to chair.

The Committee recessed at 11:10 a.m. for the Democrats to caucus. Committee reconvened at 11:20 a.m.

Representative Shomshor called the meeting back to order and Representative Thomas moved to consider SF 2405 by the Subcommittee as a Whole. Representative Thomas was recognized for opening remarks on SF 2405. no discussion from the Subcommittee, Representative Thomas gave closing remarks and moved the bill. SF 2405 passed the Subcommittee as a Whole by a voice vote. Thomas moved to arise the Subcommittee as a Whole and to consider SF 2405 as a Committee. Thomas gave closing remarks on SF 2405 and moved the bill. By a roll call vote of 25-0 the bill passed out of Committee.

Representative Shomshor recognized Representative Palmer for opening remarks on HF 2652. Amendment 2652.507 was offered by Representative Frevert, and she was recognized for opening remarks. Discussion followed. Amendment 2652.507 failed by a voice vote. Back on the HF 2652, Representative Palmer gave closing remarks and moved the bill. By a roll call vote of 23-2, HF 2652 The bill now moves to the House Floor as a Ways and passed the Committee. Means Committee bill.

Representative Shomshor called up HF 2562 for consideration. Before opening comments, the Committee recessed at 11:35 a.m. for Republicans to caucus. The Committee reconvened at 11:50 a.m.

Representative Shomshor called the meeting back to order and recognized Representative Huser for opening remarks on HF 2562. Amendment 2562.703 was introduced and Representative Huser gave opening remarks on the amendment.
