The meeting convened at 9:10 A.M.

The Roll Call was taken.

The minutes of the previous meeting were approved.

The chair recognized Rep. Jochum for the reading in of SF 2424 - An Act concerning public retirement systems and other employee benefit related matters, including the public safety peace officers' retirement, accident, and disability system, the Iowa public employees' retirement system, the statewide fire and police retirement system, and the judicial retirement system, including implementation and transition provisions, and providing effective and retroactive applicability dates.

The chair recognized Rep. Jochum for amendment 502 to SF 2424.

The committee recessed at 9:50.

The committee resumed at 11:30.

The chair asked the committee to consider SF 2424 as a subcommittee of the whole, and there were no objections.

The chair recognized Rep. Jochum for consideration of SF 2424.

The chair recognized Rep. Jochum for consideration of amendment 705 to to SF 2424.

The committee divided amendment 705 into Division A and B as follows:  
Division A being lines 3-26 and 47-50 on page 1 and lines 1-14 on page 2.  
Division B being lines 27-46 on page 1 and lines 15-50 on page 2.

Rep. Jochum moved to withdraw division A from amendment 705 to SF 2424. The motion carried.

Rep. Jochum moved amendment 705 to SF 2424. The amendment carried.

The chair dissolved the subcommittee of the whole.

The chair recognized Rep. Jochum for consideration of SF 2424.

The chair recognized Rep. Jochum for consideration of amendment 705 to SF 2424.

Rep. Jochum asked the committee to divide amendment 705 into Division A and B as follows: Division A being lines 3-26 and 47-50 on page 1 and lines 1-14 on page 2. Division B being lines 27-46 on page 1 and lines 15-50 on page 2.

Rep. Jochum withdrew Division A of the amendment.

The motion carried.

Rep. Jochum moved SF 2424 as amended by 705.

SF 2424 as amended by 705 passed, 12 ayes 8 nays 1 not voting.
