Seeing a quorum, Committee Chair Ragan called the meeting to order at 3:10 p.m.

Senator Johnson made a motion to approve the previous meeting's minutes. The motion was seconded by Senator Kreiman and passed unanimously by a short form vote.

Senator Ragan recognized Senator Bartz for introduction of gubernatorial appointees Ghada Hamdan-Allen and Keith Gatrost to the Iowa Autism Council and Steven Hagemoser to the Commission for the Blind. Senator Bartz recommended approval of the appointees and asked for a short form vote. The appointees were approved and move to the En Bloc calendar.

Senator Ragan recognized Senator Dotzler for introduction of gubernatorial appointee Cathy Young to the Iowa Autism Council. Senator Dotzler recommended approval of the appointee and asked for a short form vote. The appointee was approved and moves to the En Bloc calendar.

Senator Ragan recognized Senator Seymour for introduction of gubernatorial appointees Patrick Westhoff and Charles Wadle to the Iowa Autism Council and Daniel Harkness to the Board of Behavioral Science.
