Amendment 503 to Amendment 702 presented by Representative Lukan. Discussion by Representative Kuhn, and Whitead. Amendment 503 to Amendment 702 failed by roll call vote, division and record requested. 11 aye, 9 nay, 1 excused. Voting aye were Alons, Baudler, Hagenow, Lukan, S. Olson, Rayhons, Sands, Tjepkes and Worthan. Voting nay were Burt, Bell, Berry, Bukta, Heddens, Kressig, Kuhn, Lykam, Reichert, Whitaker and Whitead.
