REVISED status of SF 43 on floor of House.

The following bill was assigned: HF 397: A bill for an act relating to township property tax levies for emergency services and providing an applicability date.

Both parties called a caucus.

The Chair recognized Representative Ford for SF 43: A bill for an act relating to the abatement or refund of property taxes for certain religious, literary, and charitable societies and including effective and retroactive applicability date provisions. Opening remarks were made, discussion held, closing remarks made and Representative Ford moved the bill. The bill passed 11 yes, Wagner, Arnold, Deyoe, Grassley, Roberts, Sorenson, Tjepkes, Van Engelenhoven and Windschitl no. Taylor absent

The Chair recognized Representative Kressig for HSB 206: A study bill relating to county recorders by making changes to fees charged by the county recorder, information required to be endorsed on certain recorded documents and instruments, and standards for indexes maintained by the county recorder. Opening remarks were made. Representative Kressig was recognized for Amendment 206.701. Opening remarks were made, discussion held and Amendment 206.701 passed short form. Closing remarks were made and Representative Kressig moved the bill. HSB 206 passed as amended on a unanimous vote. Taylor absent. This will go to the floor as a Committee Bill.

The Chair recognized Representative Huser for HSB 207: An Act relating to public notice requirements for meetings of boards of township trustees. Opening remarks were made, discussion held and Representative Huser moved the bill. HSB 207 passed on a unanimous vote. Taylor absent. This will go to the floor as a Committee Bill.

The Chair recognized Representative Huser for HF 216: An Act relating to what constitutes a pioneer cemetery. Opening remarks were made. There being no questions or comments, Representative Huser moved the bill. HF 216 passed on a unanimous vote. Taylor absent. This will go to the floor as HF 216.

There being no other business, Representative Kressig moved adjournment. The meeting adjourned.
