Consideration of HF 417, previously deferred, led by Representative Reichert. Continuation of discussion by Representatives Alons, Lukan, Hagenow, Sands, Baudler, Heddens, Bell, and guest Fred Scaletta from the Department of Corrections. HF 417 passed by roll call vote; 12 aye, 7 nay, 2 excused. Voting aye were Representatives Lykam, Burt, Baudler, Bell, Bukta, Heddens, Kressig, Kuhn, Reichert, Sands, Whitaker, and Whitead. Voting nay were Representatives Alons, Hagenow, Lukan, S. Olson, Rayhons, Tjepkes, and Worthan.

Excused were Representatives Berry and R. Olson.

HF 417 will pass to the House Floor as a Committee Bill.
