The Commerce Committee met January 19, 2010 at 1:06 p.m. in room 103. The meeting was called to order by Chairwoman Janet Petersen. Roll call was taken and a quorum was present.

The minutes from the previous meeting were approved.

Rep. Petersen recognized Rep. Paul Shomshor for an introduction of HSB 524. Following discussion, Rep. Petersen recognized Rep. Shomshor for closing comments. Rep. Shomshor then moved the bill. Roll was called and the bill passed 22-0, with all present voting aye. The bill will pass to the House floor as a committee bill.

The committee dissolved at 1:14 p.m. for caucus to discuss HSB 530.

At 2 p.m., Rep. Petersen recessed the committee until 5 p.m.

Upon reconvening at 5:06 p.m., Rep. Petersen recognized Rep. Tyler Olson for an introduction of HSB 530. Rep. T. Olson introduced Amendment 530.148. After discussion, Rep. T. Olson offered closing comments and moved the amendment. Amendment 530.148 passed on a roll call vote, 21-0, with all present voting aye. (Rep. Dave Jacoby excused.)

Rep. Petersen opened the floor to discussion of HSB 530, as amended. Following discussion, Rep. Petersen recognized Rep. T. Olson for closing remarks. Rep. T. Olson then moved the bill. Roll was called. With a vote of 14 ayes and 7 nays, the bill was declared to have passed the committee and will pass to the House floor as a committee bill. Voting aye were Reps. Petersen, Reasoner, Kelley, Kressig, Oldson, D. Olson, T. Olson, Quirk, Reichert, Shomshor, Struyk, Wenthe, Windschitl, and Zirkelbach. Voting nay were Reps. Soderberg, Helland, Lukan, Pettengill, Sands, Sorenson, and Wagner.

Rep. Bob Kressig moved to adjourn. The meeting adjourned at 5:21 p.m.
