Representative Willems then moved passage of [HSB 553](#), as amended. [HSB 553](#) passed the Judiciary Committee 20-0, with Chairperson Swaim absent and not voting. Vice-Chairperson Palmer announced that [HSB 553](#), having received sufficient votes for passage, would pass to the floor of the House as a committee bill. There being no further business to come before the committee, Representative Olson, R. moved to arise. The committee adjourned at 2:45 p.m.
