Chair Smith recognized Rep. Wendt for opening remarks on HSB 609. Rep. Wendt moved the bill. Roll call vote was taken and HSB 609 passed 21-0, with all present voting aye. Having received a constitutional majority, the bill moves onto the floor of the house as a Committee Bill.

Chair Smith recognized Rep. Thede for opening remarks on HSB 626. Discussion followed. Chair Smith recognized Rep. Thede for closing remarks and Rep. Thede moved the bill. Roll call vote was taken and HSB 626 passed 21-0, with all present voting aye. Having received a constitutional majority, the bill moves onto the floor of the house as a Committee Bill.

Chair Smith recognized Rep. Petersen for opening remarks on HSB 682. Discussion followed. Chair Smith recognized Rep. Petersen for closing remarks. Amendment 724 was adopted to HF 2129 by unanimous consent by voice vote. Rep. T. Olson moved HF 2129 as amended. Roll call vote was taken and HF 2129 passed 21-0, with all present voting aye. Having received a constitutional majority, the bill moves onto the floor of the house as a Committee Bill.

Chair Smith recognized Rep. Heddens for opening remarks on HF 2150. Chair Smith recognized Rep. Heddens for opening remarks on Amendment 706. Rep. Heddens requested that Amendment 706 be divided as follows: Division A: lines 1-3; Division B: lines 4-5. Rep. Heddens moved Division A to Amendment 706 and it was adopted by unanimous consent by voice vote. Rep. Heddens withdrew Division B of Amendment 706. Chair Smith recognized Rep. Heddens for opening remarks on Amendment 695. Rep. Heddens moved Amendment 695 to HF 2150 and it

was adopted by unantimous consent by voice vote. Rep. heddens was recognized
for closing comments on HF 2150 as amended and Rep. Heddens moved HF 2150 as
amended. Roll call vote was taken and HF 2150 passed 21-0, with all present
voting aye. Having received a constitutional majority, the bill moves onto the
floor of the house as a Committee Bill.
