The meeting was called to order by Chair, Representative Gaskill. Roll was called with a quorum being present. The minutes of the previous meeting were approved as received electronically. There were no bills to be assigned. Both parties called for a caucus. Upon return, Representative Windschitl was recognized for opening comments on SF 2328: A bill for an act allowing county treasurers to collect delinquent taxes on behalf of the department of revenue from a person renewing a vehicle registration, requiring a plan for the collection of court debt by county treasurers, and providing a fee. He was recognized for amendment 2328.1728 and following opening comments he moved the amendment short form, which was passed. Representative Windschitl moved passage of the bill. There were 20 ayes, Representatives Gaskill, Kressig, Wagner, Arnold, Burt, Cohoon, Deyoe, Ford, Grassley, Huser, Isenhart, Kuhn, Olson, D., Roberts, Schueller, Tjepkes, VanEngelenhoven, Whitead, Winckler and Windschitl. Representative Sorenson voted nay. The bill will go to the floor of the House as amended. Representative Olson was recognized for opening comments on SF 2265: A bill for an act establishing smart planning principles, establishing guidelines for the adoption of certain comprehensive plans and land development regulations, and providing for the establishment of a smart planning task force.

Representative Olson was recognized for amendment 2265.1872, after discussion he moved passage. The amendment passed short form 20-1. Representative Olson was recognized for amendment 2265.1862, after discussion he moved passage short form. It passed unanimously. Representative Olson gave closing comments and moved the bill as amended. It passed 11 ayes, Representatives Gaskill, Kressig, Burt, Cohoon, Ford, Isenhart, Kuhn, Olson, Schueller, Whitead, Winckler. 10 nayes

Representatives Wagner, Arnold, Deyoe, Grassley, Huser, Roberts, Sorenson, Tjepkes, Van Engelenhoven,

Windschitl. The bill will go to the floor of the House as amended. Leadership from both sides expressed appreciation for the work of the members. There being no other business, Representative Huser moved adjournment. The meeting was adjourned.
