Representative Thomas made opening comments on Amendment 4736 and discussion followed. Amendment 4736 was adopted by voice vote. Representative Thomas then moved HF 2305 as amended. The clerk called the roll call vote. HF 2305 as amended passed unanimously 25-0 with all present voting aye.
