Representative Shomshor called the Committee to order at 9:50 AM. Clerk called the roll. Minutes from the previous meeting were approved.

Representative Shomshor relinquished the chairmanship to Representative T. Olson. Representative T. Olson asked for unanimous consent to convene a Subcommittee as a Whole for HF 2138. Representative T. Olson recognized Representative Shomshor for opening comments on HF 2138. Discussion followed. Representative Shomshor gave closing remarks and moved HF 2138. Representative T. Olson asked for unanimous consent for a voice vote on HF 2138. HF 2138 passed unanimously by voice vote out of the Subcommittee as a Whole in short form. Representative T. Olson moved to dissolve the Subcommittee as a Whole. Hearing no objections, the full committee resumed. Representative Shomshor gave opening comments on HF 2138 and hearing no discussion, moved the bill. The clerk called the roll call vote and HF 2138 passed, 20 ayes and 0 nays with all members present voting aye.

Representative T. Olson returned the Chairmanship to Representative Shomshor. Representative Shomshor asked for unanimous consent to convene a Subcommittee as a Whole for HF 2531. Representative Shomshor recognized Representative T. Olson for opening comments on HF 2531. Republicans caucused. Upon return to committee, discussion followed. Representative T. Olson gave closing remarks and moved HF 2531. Representative T. Olson asked for unanimous consent for a voice vote. HF 2531 passed unanimously by voice vote out of the Subcommittee as a Whole. Representative Shomshor moved to dissolve the Subcommittee as a Whole. Hearing no objections, the full committee resumed. Representative T. Olson gave opening comments on HF 2531, and after discussion, moved the bill. The clerk called the roll call vote and HF 2531 passed, 13 ayes and 12 nays. Those voting aye were Representatives Shomshor, T. Olson, Bell, Bukta, Frevert, Huser, Isenhardt, D. Olson, Petersen, Schueller, Steckman, Thomas and Willems. Those voting nay were Representatives Sands, Forristall, Grassley, Hagenow, Helland, Kaufmann, L. Miller, Pettengill, Reasoner, Struyk, Wagner and Windschitl.

The floor was then opened to discussion. Representative Isenhardt asked for unanimous consent to take up HSB 739, which was denied.

Seeing no further business, Representative D. Olson moved to adjourn at 10:20 AM.
