Representative Shomshor called the Committee to order at 12:55 PM. Clerk called the roll. Minutes from the previous meeting were approved. Assignment of bills to be taken up in the current meeting: [SF 2387](#) Thomas [SF 2388](#)

Shomshor Representative Shomshor asked for unanimous consent to take up the two bills in the current meeting in Subcommittees as a Whole. Hearing no objections, Representative Shomshor relinquished the chairmanship to Representative T. Olson and he convened a Subcommittee as a Whole for [SF 2388](#). Representative T. Olson recognized Representative Shomshor for opening comments on [SF 2388](#). Discussion followed.

Representative Shomshor gave closing remarks and moved [SF 2388](#). Representative T. Olson asked for unanimous consent for a voice vote on [SF 2388](#). [SF 2388](#) passed unanimously by voice vote out of the Subcommittee as a Whole in short form. Representative T. Olson moved to dissolve the Subcommittee as a Whole. Hearing no objections, the full committee resumed. Representative Shomshor gave opening comments on [SF 2388](#) and hearing no discussion, moved the bill. The clerk called the roll call vote and [SF 2388](#) passed, 15 ayes and 8 nays. Those voting aye were Representatives Shomshor, T. Olson, Bell, Bukta, Forristall, Frevert, Isenhardt, L. Miller, D. Olson, Petersen, Reasoner, Schueller, Steckman, Thomas and Willems.

Those voting nay were Representatives Grassley, Hagenow, Helland, Kaufmann, Pettengill, Struyk, Wagner and Windschitl. Representative T. Olson returned the Chairmanship to Representative Shomshor. Representative Shomshor asked for unanimous consent to convene a Subcommittee as a Whole for [SF 2387](#). Representative Shomshor recognized Representative Thomas for opening comments on [SF 2387](#). Representative Thomas gave closing remarks and moved [SF 2387](#). Representative Thomas asked for unanimous consent for a voice vote. [SF 2387](#) passed unanimously by voice vote out of the

Subcommittee as a Whole. Representative Shomshor moved to dissolve the Subcommittee as a Whole. Hearing no objections, the full committee resumed. Representative Thomas gave opening comments on [SF 2387](#), and after discussion, gave closing comments and moved the bill. The clerk called the roll call vote and [SF 2387](#) passed, 21 ayes and 1 nays. Those voting aye were Representatives Shomshor, T.
