Chair Cownie gave opening remarks and recognized Representative Helland for HF 6 relating to searchable database. The subcommittee report of Helland, Jorgensen was submitted and signed, Hunter declined. Representative Helland gave opening remarks and asked to take up amendment HF6.104, discussion followed and the Chair moved the amendment short form and passed. A discussion was held on HF 6 as amended and on a roll call vote passed with 23 ayes, 0 nays.
