The Meeting resumed with Rep. Miller turning the chair over to Vice Chair Rep. Fry. Rep. Fry recognized Rep. Miller for consideration and opening remarks of HSB 25, a bill allowing an advanced registered nurse practitioner to sign a death certificate. There was an amendment, HSB25.567. Discussion followed. Rep. Miller moved the amendment by short form. The amendment passed with one Nay by Rep. Pearson. Rep. Fry recognized Rep. Miller for closing remarks on HSB 25. Rep. Miller just moved the bill as amended. Roll was called, with 18 ayes and 2 Nays, Rep. Massie and Rep. Pearson Rep. Wessel-Kroeschell absent.

Rep. Fry recognized Rep. Miller for consideration and opening remarks on HSB 89, a bill relating to investigative costs of the Medicaid fraud control unit, there was an amendment HSB89.580. Discussion followed. Rep. Miller moved the amendment by short form. The amendment passed. Rep. Fry Vice-Chair asked Rep. Miller for closing remarks on HSB 89. Rep. Miller moved HSB 89 as amended. Roll was called. There were 19 ayes, and 2 absent, Reps. Wessel-Kroeschell and Jorgensen.

Rep. Miller recognized Rep. Schulte for HF 60, a bill relating to the Alzheimer disease task force report, and opening remarks. There was an amendment HF60.528. Discussion followed. Rep.
