Chair Cownie recognized Representative Pettengill for opening remarks on HF 42: A bill for an act repealing the Iowa plumber, mechanical professional, and contractor licensing Act. The subcommittee report of Pettengill and Kaufmann was signed and Quirk declined. Representative Pettengill gave opening comments and asked permission to take up Amendment .590, discussion followed, the amendment was adopted. Pettengill gave closing remarks and Chair Cownie moved HF 42 as amended as a committee bill on a roll call vote. 17 ayes, 5 nays, 1 absent.
