Chair Baudler called the meeting to order at 1:05PM.

Roll call was taken and a quorum was present.

As there were no corrections, amendments, and/or deletions to the February 16th meeting minutes, they were unanimously approved.

Subcommittees are assigned as follows:

HSB 127 was assigned to a subcommittee of Representative Hagenow as chair, Representative Olson S., and Representative Abdul-Samad.

HSB 137 was assigned to a subcommittee of Representative Hagenow as chair, Representative Shaw and Representative Berry.

HF 291 was assigned to a subcommittee of Representative Tjepkes as chair, Representative Baudler and Representative Olson, R.

Both Democrats and Republicans held a caucus starting at 1:10PM and the meeting was called to order again at 1:35pm.

Chair Baudler recognized Representative Shaw for HSB 67. Representative Shaw then recognized Chair Baudler for opening remarks on HSB 67. A study bill for requiring an arrested person to submit a DNA sample if the arrest is for a felony and providing for the reimbursement of costs. Representative Baudler then gave opening remarks on Amendment 534. After answering questions from the committee on the amendment, the amendment was voted on. The Amendment 534 passed unanimously. After answering questions from the committee regarding the amended study bill, Representative Shaw moved HSB 67. This study bill was voted on and passed unanimously 21-0 and will be moved to floor as a Committee bill.

The chair recognized Representative Shaw for opening remarks on HSB 69. A study bill for modifying the criminal offense of interference with official acts. After answering questions from the committee Representative Shaw gave closing comments. He moved the bill and HSB 69 was voted on and passed 13-8. Those voting nay were Representatives Kressig, Abdul-Samad, Berry, Gaines, Muhlbauer, Olson R., Swaim, and Wolfe. This bill will move to the floor as a Committee Bill.

As there was no other business to come before the committee, Representative Olson, R. moved we adjourn. The meeting was adjourned at 1:50PM.
