The House Judiciary Committee was called to order at 4:07 PM in Room 102 by Chairperson Anderson.

Roll call was taken and Chair Anderson declared a quorum was present.

The minutes from the previous meeting were approved as previously distributed.

Republicans and Democrats went to caucus at 4:12 P.M.
The House Judiciary Committee reconvened at 4:43 P.M.

Chair Anderson recognized Representative Baltimore for opening comments on HSB 10. Representative Baltimore was recognized for opening comments on Amendment .564 to HSB 10. A sense amendment was passed with unanimous consent to change the title of the amendment from House File 10 to HSB 10. Discussion on amendment HSB10.564 followed. Representative Baltimore moved passage of Amendment .564. The amendment passed by a voice vote. Discussion of HSB 10 as amended followed. Representative Baltimore was recognized for closing remarks on HSB 10.

The House Judiciary Committee recessed at 5:05 P.M. for the House of Representatives to recess for the day.
The House Judiciary Committee reconvened at 5:10 P.M.

Representative Baltimore finished his closing comments and moved passage of HSB 10 as amended. HSB 10 passed the Judiciary Committee 11-10, those voting nay were Representatives Swaim, Gaines, Lensing, Oldson, Olson, R., Olson, T., Rogers, Smith, M., Wessel-Kroeschell, Wolfe.

Chairperson Anderson announced that HSB 10 having received a constitutional majority, would pass to the Floor of the House as a committee bill.

Chair Anderson announced that a revised agenda would be published for the February 24th meeting.

There being no further business to come before the committee, Representative Heaton moved to adjourn.
