Chair Anderson recognized Representative Kaufmann for opening comments on HSB 92. Representative Kaufmann was recognized for opening comments on Amendment 92.868. Amendment .868 passed by a voice vote. Discussion on HSB 92 followed. Representative Kaufmann was recognized for closing comments on HSB 92. Representative Kaufmann moved HSB 92 as amended. HSB 92 passed the Judiciary Committee 13-8, those voting nay were Representatives Swaim, Gaines, Lensing, Oldson, Olson, R., Olson, T., Wessel-Kroeschell, and Wolfe. Chair Anderson announced that HSB 92, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Baltimore for opening comments on HSB 96. Representative Baltimore was recognized for opening comments on Amendment 96.686. Amendment .686 passed by a voice vote. Discussion on HSB 96 followed. Representative Baltimore was recognized for closing comments on HSB 96. Representative Baltimore moved HSB 96 as amended. HSB 96 passed the Judiciary Committee 17-4, those voting nay were Representatives Gaines, Olson, R., Smith,M. and Wessel-Kroeschell. Chair Anderson announced that HSB 96, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Pearson for opening comments on HSB 38. Representative Pearson was recognized for opening comments on Amendment 38.735. Amendment .735 passed by a voice vote. Discussion on HSB 38 followed. Representative Pearson was recognized for closing comments on HSB 38. Representative Pearson moved HSB 38 as amended. HSB 38 passed the Judiciary Committee 20-1, the nay vote by Representative Wolfe. Chair Anderson announced that HSB 38, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Garrett for opening comments on HF 166. Following opening comments, Representative Hagenow asked to defer to the 2nd amendment. Representative Hagenow was recognized for opening comments on Amendment 166.759. Amendment .759 passed by a voice vote. Representative Garrett was recognized for opening comments on Amendment 166.412. Amendment .412 passed by a voice vote. Discussion on HF 166 followed. Representative Garrett was recognized for closing comments on HF 166. Representative Garrett moved HF 166 as amended. HF 166 passed the Judiciary Committee 11-10, those voting nay were Representatives Swaim, Gaines, Heaton, Lensing, Oldson, Olson, R., Olson, T., Smith,M., Wessel-Kroeschell and Wolfe. Chair Anderson announced that HF 166, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson asked for unanimous consent to consider HSB 185 and HSB 150.

With unanimous consent, Chair Anderson recognized Representative Rogers for opening comments on HSB 185. Representative Rogers was recognized for opening comments on Amendment 185.897. Amendment .897 passed by a voice vote. Discussion on HSB 185 followed. Representative Rogers was recognized for closing comments on HSB 185. Representative Rogers moved HSB 185 as amended. HSB 185 passed the Judiciary Committee 21-0. Chair Anderson announced that HSB 185, having received a constitutional majority would pass to the Floor of the House as a committee bill.
