The Economic Growth/Rebuild Iowa Committee convened at 2:45 PM. Roll call was taken at the start of the meeting. Chair Grassley asked for any revisions to the previous meetings minutes. Hearing none, Chair Grassley moved to approve the minutes and the motion was unanimously carried.

Chairman Grassley announced both parties would separately caucus at 2:50. The committee reconvened at 3:20.

Chair Grassley reassigned the following bill assignment: HF 413 to Thomas (Chair); Hall, Lofgren

Chair Grassley announced a subcommittee of the whole and after unanimous consent, the meeting was moved to a subcommittee of the whole and HSB 183 was passed unanimously out of subcommittee of the whole. Representative Grassley then moved that the subcommittee of the whole be adjourned and the meeting to continue, with after unanimous consent the subcommittee of the whole was adjourned and the meeting continued.

Chair Grassley recognized Representative Schultz for opening remarks on HSB 183. After stating his opening remarks, and hearing remarks by other members of the committee, Representative Schultz moved HSB 183; the bill was carried unanimously, 20-0. The bill will move to the House floor as a committee bill.

Chair Grassley once again recognized Representative Schultz for opening remarks on HF 305. This is a bill for an act relating to the use of floodplain maps published by the federal emergency management agency. After stating his opening remarks, and hearing remarks by other members of the committee, Representative Schultz moved HF 305 and the bill was carried 12-8. Those opposed were Representatives Thomas, Hall, Heddens, Jacoby, Miller, Running-Marquardt, Steckman and Wittneben. The bill will move to the House floor as a committee bill.

Chair Grassley announced that a short caucus with specific members would occur following the meeting. With no further business to come before the meeting, Representative De Boef moved for adjournment and the motion was unanimously carried.
